# **Course Description**

Develop a diverse and fundamental understanding of chemical engineering principles through invited seminar presentations from experts at UF and other institutions

- 2. Assess the content of presentations and provide critical insight into potential applications and future research directions of the topic.
- 3. Understand and apply basic laboratory safety rules in their research environment.

### Course Schedule

The course consists of invited seminars held on Mondays during Period 3 (9:35-10:25 am). The topics of the presentations represent the diversity of chemical engineering research topics and vary week-to-week and semester-to-semester. Other chemical engineering seminars may be announced during the semester, often for interviewing potential faculty hires. It is critical to the success of our department that all seminars are well attended. Students will receive seminar announcements from department staff reminding them of upcoming seminars. It is expected that all students check their UF email account regularly to stay up to date on upcoming seminars.

# Attendance Policy, Class Expectations, and Make-Up Policy

Seminars from invited speakers will be given virtually over zoom. **Attendance** is highly required and is taken before each seminar begins and after the seminar ends. Students must arrive 2 min prior to the seminar start to sign up attendance sheets (in NEB 0201) or log in the zoom. Students must remain at the seminar for the entire class.

**Students are allowed as many as two absences from seminar for any reason.** Students anticipating absences due to religious observances must inform the instructor (Prof. Yeongseon Jang), consistent with UF Policy. Additional excused absences must be consistent with university policies in the Graduate Catalog (<a href="https://catalog.ufl.edu/graduate/regulations">https://catalog.ufl.edu/graduate/regulations</a>) and require appropriate documentation. If students miss seminar due to their attendance at conferences or workshops, verified through notice from the student's advisor, their absence will not count towards the two allowed absences.

Students with more than the allowed excused absences from seminar must attend a **Make-Up seminar**, which may be a chemical engineering seminar held outside of regular class meeting times (e.g., research seminars held on days besides Monday) or a seminar where the topic is related to chemical engineering. These seminars can be held in another department within the College of Engineering or in the Departments of Chemistry of Physics. Attending seminars from other departments may be acceptable but they must be pre-approved by the instructor.

Attendance at any Make-Up seminar must be documented using the Make-Up Seminar Form (available in the graduate office, contact Ms. Shirley Kelly) and 1 page summary of the seminar contents.

# **Evaluation of Grades & Grading Policy**

Course grades will be assigned based solely on the attendance to seminars. Students will drop one letter grade for each unexcused absence from seminar. Additional excused absences beyond the two allowed absences require appropriate documentation and must be consistent with university policies in the graduate catalog.

#### **In-Class Recording**

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. The only allowable purposes are (1) for personal educational use, (2) in connection with a complaint to the university, or (3) as evidence in, or in preparation for, a criminal or civil proceeding. All other purposes are prohibited. Specifically, students may not publish recorded lectures without the written consent of the instructor.

A "class lecture" is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and delivered by any instructor hired or appointed by the University, or by a guest instructor, as part of a University of Florida course. A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or lecturer during a class session.

Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
