The analysis and automatic control of process systems in chemical engineering.

- 3. The student will be able to use and tune proportional-integral-derivative controllers
- 4. The student will be able to analyze the performance and stability of linear control systems, both open loop and closed loop

Course Topics (The timing is approximate as I slow down or accelerate according to my perception of how well the students comprehend what I am lecturing on).

- Introduction to feedback and feedforward control (1<sup>st</sup> week)
- Nonlinear state space models and their linearization (weeks 2-4)
- Laplace transforms, transfer functions, and open-loop stability (weeks 5-6)
- First-order plus time delay systems and approximate transfer functions from experimental data (weeks 7-8)
- The PID control law and low-pass filtering (week 8)
- Controller tuning methods for first order plus time delay systems (weeks 8-9)
- Velocity and position forms of the discrete PID control law (week 9)
- Frequency response analysis (weeks 10-11)
- Closed-loop stability analysis (weeks 12-13)
- Controller tuning methods for any transfer function model (week 14)

• Optional topics, depending on time availability: Cascade control, design of feedforward control, controller design for open-loop unstable systems (week 15)

## Detailed Explanation of Grading

1. For each student, Overall Points are calculated as follows:

Overall Points = 0.375 \* Exam1 Grade + 0.375 \* Exam2 Grade + 0.20 \* Homework/Classwork Grade + 0.05 \* Class Participation Grade

#### where

- Exam grades are 0-100
- Homework/Classwork Grade = (Total homework points earned)/(maximum possible points) \*100
- Class participation grade:

Students will receive an 88 if they attend all classes (aside from university excused absences) but do not contribute to class discussions, or ask questions, or correct lecture errors, something encouraged and appreciated. Then the grade is reduced according to the frequency of unexcused class absences and raised according to how active a participant they are.

#### 2. Grades are then decided as follows:

Division between A and A-: The division between the lowest A and the highest A- occurs in students who averaged overall score 87.5 +/- 2.5. As it is undesirable to have a student with 87.49 obtain a different grade from a student with 87.51, instead of having a hard boundary at 87.5, the students are first sorted in decreasing order of overall points and the division occurs at the largest gap (difference). So, if there are five students with overall points 89.6, 88.4, 87.3, 85.2, and 85.1, 87.3 is assigned the lowest A and 85.2 the highest A-.

Divisions between lower grades are decided in the same manner, with one exception. A minimum of 50% overall points is required for a student to earn a C.

Division between A- and B+: 82.5 +/- 2.5Division between B+ and B: 77.5 +/- 2.5Division between B and B-: 67.5 +/- 2.5Division between B- and C+: 62.5 +/- 2.5Division between C+ and C: 57.5 +/- 2.5

Division between C and C-: 50 (no gap here, 50 is C, 49.9 C-)

Division between C- and D+ : 37.5 +/- 2.5Division between D+ and D : 17.5 +/- 2.5

Division between D and D-: 2.5 +/- 2.5 (never happens)

E: Pursued for students with honesty violations

The class participation grade is designed so that students who attend class regularly will not have an A grade lowered even if they never speak. It helps attending students with lower overall points.
